18/098	<p><u>WARD & COUNTY COUNCILLORS TO ADDRESS THE MEMBERS IF PRESENT</u></p> <p><i>WARD COUNCILLOR PETER CHILLINGWORTH / COUNTY COUNCILLOR ANNE BROWN</i></p> <p>Cllr Brown spoke briefly on the following:</p> <ul style="list-style-type: none"> ❖ Highway funding with regards the A120 and A12 ❖ Kevin Bentley becoming the new Highways Portfolio Holder ❖ Garden Communities ❖ Concerns regarding the rural road from Great Tey through to Bures – an update from Joe Hazleton was expected shortly. ❖ The speed outside Chappel Primary School was unlikely to receive a reduction in speed limit as this was against policy. The Local Highways Panel could consider looking at improving the path at the back of the school. It was raised that while the current owners of the Public House allowed parents to park in the carpark this was a voluntary arrangement and a change in ownership could alter this. It was agreed that the Clerk would write a letter to the Public House asking for this arrangement to be agreed on a more formal and permanent arrangement. Cllr Knights would also broach this face to face. Cllrs raised the issue of the amount of traffic on the road, along with the size of vehicles coupled with their being no footpath. <p>Cllr Neubauer brought up the issue of an over flowing inspection chamber which took place last week. While investigating they found a lump of tarmac the size of a football to be the cause of the issue. Cllr Neubauer asked Cllr Brown to investigate further as the road along the A1124 had recently had remedial highways works and this could be the source of the tarmac.</p> <p>Cllr Neubauer asked Cllr Brown to pass on thanks to the contractors that had been working on the drainage and surface works on Swan Street – the Foreman had been very helpful during the works.</p> <p>Cllrs congratulated Cllr Chillingworth on becoming Mayor of Colchester on the 23rd May. Cllr Chillingworth spoke briefly on the following:</p> <ul style="list-style-type: none"> ❖ Cllr Chapman would try to cover Chappel meetings in his absence. ❖ Local Plan Part 1 (housing, infrastructure and garden communities) is likely to be decided by the Inspector before Part 2. ❖ Knights Farm – a Freedom of Information request had been sought by a resident. The findings had been submitted to Colchester Borough Council to be looked into. ❖ He confirmed that while he was not able to sit on the Planning Committee he would be able to represent his Ward.
